 1. 25 years in case he/she is a PG student
 2. 28 years in case he/she is a Research student;
 - iii. He/she must have a minimum of 75 percent attendance in all courses taken by him/her during previous semester(s) except those who are in the first semester.
 - iv. He/she must not have any academic arrear i.e. he/she must have successfully completed all the courses he took during the previous semesters of the programme of studies in which he/she is presently enrolled; such persons who have failed and/or awarded I grade and/or detained due to shortage of attendance in any of the courses, during the previous semester(s) of the programme of studies in which he/she is presently enrolled shall not be eligible to contest the election.
 - v. He/she must not have any fee arrears in the year of contesting the election.
 - vi. He/she must not have a previous criminal record, that is, he should not have been tried and/or convicted of any criminal offence or misdemeanour.
 - vii. His/her conduct in the University must have been exemplary and he/she must not have been subjected to any disciplinary action by the University authorities.
- b. Election of a Candidate shall be declared null and void in the event of nonconformity with any of the above rules or guidelines.



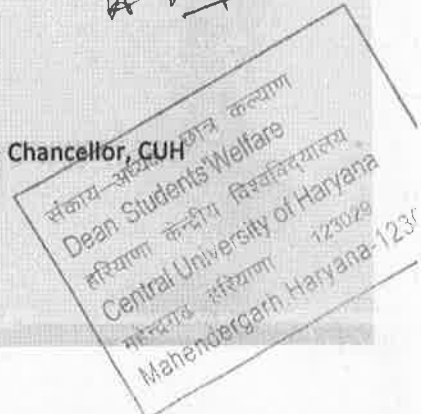

In Compliance with the provisions of Central University Act 2009, Students Council is required to be constituted for the academic year 2016-17. Statute 36 of the act provides that-


“There shall be constituted in the university, a Students’ Council for every academic year consisting of-

- i. The Dean of Student Welfare who shall be the Chairman of the council;
- ii. 20 students to be nominated by the Academic council on the basis of merit in academic, sports and extra-curricular activities; and
- iii. 20 students to be elected by students as their representatives.

The Central Universities Act 2009 provides for Students Council consisting of forty members. However, there is no provision of office bearers or student union. The representation of forty students from different departments is proposed as follow:

4. Other Issues

- i. The students raised the issues related to the cleanliness in new academic building. For this, Hon'ble V.C immediately directed Mr. Mahesh Bhardwaj and Mr. Balbir to place dustbins in all the departments of new academic building, and to deploy more staff to solve the problem of cleanliness.
- ii. The students are facing problems in commuting from the main road of JANT Village to the university.
- iii. Few students raised some issued related with scholarships/fellowships. The DSW office was directed to take care all such issues.

- vi. The students of Hotel & Tourism Department raised the issues of non-availability of books in library and lab experiments of non-veg dishes. The concerned Head/Incharge was directed to pick all the books of his department from library and to set a departmental library. He was further suggested to explore the possibilities of lab experiments of non- veg items in other institutions on regular interval.

2. Library Related Issues

- i. The students demanded that the timings of E-Lab and library should be increased. It was decided that the matter will be discussed with Incharge, library to explore the possible solutions.
- ii. The students reported that placement of books in library is not proper. Sometimes it took hours to find a book. Incharge, Library will be requested to take necessary action in this regard, even the help of students of M. Lib Science may be taken for this, as it was offered voluntarily by student representative of Library Sc. department.
- iii. The students hinted about the insufficient service of photocopier and printer in central library. It was decided that Incharge of library will take necessary actions to provide the proper photocopy and printing facilities to the students.
- iv. Looking at the problems of space and staff in central library, Hon'ble VC suggested that all life sciences departments to get the books issued from central library, and to create departmental libraries in their respective departments.

3. Hostel Related Issues

There are following problems discussed by the students related to boy's and girl's hostels and it was resolved that

- i. Arrangement of 'Reading stands' for newspapers and magazines in both hostels be made.
- ii. Provision of a small canteen/tea shop for the students in both hostels be made.
- iii. Non-functioning water cooler at first floor in boy's hostel be made functional.
- iv. Accommodation to all the girl students in girl's hostel to be made through adjustment with other resident students of girl's hostel.

The wardens of both hostels were directed to take suitable and necessary steps regarding the above mention problems.

Minutes of First Meeting of Students Council of session 2016-17, held on 09.11.2016 in Smart Class Room at 3:30 PM. The following issues were discussed during the meeting and resolved.

1. Department level issues:

- i. The students of Department of Computer Science and Department of library science raised the issue related with faculty, and availability of books. The concerned Head/Incharge was immediately directed to arrange the guest lecturers of different specializations as required by respective department. The concerned Head/Incharge were also directed by competent authority to ensure the proper availability of books of their respective department. Further, it was also decided that few more faculty members on contractual basis will be hired to resolve the problem of faculty deficiency.
- ii. The students depicted their concerns regarding the availability of studio room and cameras in the department of Journalism and Mass Communication. The matter was discussed with concerned Head/Incharge along with faculty members and accordingly were directed to take appropriate course of actions in this regard.
- iii. The students of EVS department raised the issue related to practical labs and dissertation. Appropriate directions were given by Hon'ble VC to concerned Head/Incharge to resolve the matter.
- iv. The requirement of one more class room for the department of Biochemistry was discussed and Mr. Mahesh Bhardwaj, JE was instructed to arrange the same in consultation with Head/Incharge of department.
- v. The students of Geography department communicated their concern for the availability software to conduct the practical's in the department. It was resolved that the concerned Head/Incharge will initiate the procedure for purchase of required software. It was also decided that the department of Geography will explore the possibilities to conduct the various practical's related with GIS/ remote sensing in the GIS/ Remote Sensing Center Haryana Agriculture University, Hisar.
